INTRODUCTION

The purpose of this Traffic Accommodation Strategy is to ensure that safety of all employees and public throughout the duration of the project. It is the primary goal to provide a construction site that is not only safe to the workers involved, but also to the general public that may be affected by the construction.

For the Duration of the Town of Crossfield Railway St. Revitalization project, the following traffic plan will be implemented and followed for all public and construction traffic travelling around or near the construction areas. The current posted speed of 30km/h will remain in place on the detour routes.

This Traffic Accommodation Strategy follows Alberta Transportation guidelines for temporary traffic accommodation in work zones.

PROJECT LOCATION

Town of Crossfield located in the Province of Alberta.

The traffic accommodation will be separated into 4 phases along Limit Avenue and Railway Street. Phase 3 and 4 will include sub phases that pertain specifically to vehicular/delivery access for businesses.

Phase 1 (Appendix B) – Laut Ave/ Railway St Intersection to the north side of Ross St. Vehicular access will be provided for businesses via a temporary access road east of Railway St. Phase 2 (Appendix C) – Railway St north of Laut Ave to north of Smith Ave, including west on Smith Ave to the alley. Vehicular access will be provided for businesses via a temporary access road east of Railway St.

Phase 3 (Appendix D) – Railway St north of Grey St to south of Osler St, including west on Smith Ave, Nanton Ave, and Hammond Ave to the alley ways.

Vehicular/Delivery access will be provided for businesses during Phase 3 as follows:

Phase 3a)

- Delivery access for businesses between Grey Ave, and Smith Ave will be via the lane entrance on Grey Ave.
- Delivery access for businesses between Smith Ave and Nanton Ave will be via the lane entrance on Nanton Ave.
- Delivery access for businesses between Nanton Ave and Hammond Ave will be via the lane entrances on both streets.
- Delivery access for businesses between Hammond Ave and Osler Ave will be via the lane entrances on both streets.
- Delivery access for Mountain View Financial will be east of the Osler Ave and Railway St intersection.

Phase 3b)

- Delivery access to businesses between Grey Ave, and Smith Ave will be via the lane entrances on both streets.
- Delivery access to businesses between Smith Ave and Nanton Ave will be via the lane entrance on Smith Ave.



- Delivery access to businesses between Nanton Ave and Hammond Ave will be via the lane entrance on Hammond Ave.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrances on both streets.
- Delivery access for Mountain View Financial will be east of the Osler Ave and Railway St intersection.

Phase 3c)

- Delivery access for businesses between Grey Ave, and Smith Ave will be via the lane entrance on Grey Ave.
- Delivery access to businesses between Smith Ave and Nanton Ave will be via the lane entrance on Nanton Ave.
- Delivery access to businesses between Nanton Ave and Hammond Ave will be via the lane entrance on Nanton Ave.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrance on Osler Ave.
- Delivery/Vehicular access for Mountain View Financial will be east of the Osler Ave and Railway St intersection.

Phase 3d)

- Delivery access to businesses between Grey Ave, and Smith Ave will be via the lane entrances on both streets.
- Delivery access to businesses between Smith Ave and Nanton Ave will be via the lane entrance on Smith Ave.
- Delivery access to businesses between Nanton Ave and Hammond Ave will be via the lane entrance on Hammond Ave.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrances on both streets.
- Delivery/Vehicular access for Mountain View Financial will be east of the Osler Ave and Railway St intersection.

Phase 3e)

- Delivery access to businesses between Grey Ave, and Smith Ave will be via the lane entrances on both streets.
- Delivery access to businesses between Smith Ave and Nanton Ave will be via the lane entrances on both streets.
- Delivery access to businesses between Nanton Ave and Hammond Ave will be via the lane entrance on Nanton Ave.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrance on Osler Ave.
- Delivery/Vehicular access for Mountain View Financial will be east of the Osler Ave and Railway St intersection.



Phase 4 (Appendix E) – Railway St north of Nanton Ave to south of Limit Ave, including to the alley on Hammond Ave and Osler Ave. Grey Ave from Railway St to the alley will also be closed.

Vehicular/Delivery access will be provided for businesses during Phase 4 as follows:

Phase 4a)

- Delivery access to businesses between Nanton Ave, and Hammond Ave will be via the lane entrance on Nanton Ave.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrance on Osler Ave.
- Delivery access to businesses between Osler Ave and Chisolm Ave will be via the lane entrance on Chisolm Ave.
- Delivery access to Mountain View Financial will be via a temporary access road crossing Railway St from Osler Ave.
- Delivery/Vehicular access to Carmens Bigway Foods Grocery Store will be alternating between temporary access roads crossing Railway St from Chisolm Ave, and Osler Ave, or from the temporary access road heading north from the parking lot.
- Delivery/Vehicular Access to the Shell Gas Station will be via a temporary access road from Limit Ave.

Phase 4b)

- Delivery access to businesses between Nanton Ave, and Hammond Ave will be via the lane entrances on both streets.
- Delivery access to businesses between Hammond Ave and Osler Ave will be via the lane entrance on Hammond Ave.
- Delivery access to businesses between Osler Ave and Chisolm Ave will be via lane entrance on Chisolm Ave.
- Delivery access to Mountain View Financial will be via a temporary access road crossing Railway St from Osler Ave, or from the temporary access road heading north from the parking lot.
- Delivery/Vehicular access to Carmens Bigway Foods Grocery Store will be alternating between temporary access roads crossing Railway St from Chisolm Ave, and Osler Ave.
- Delivery/Vehicular Access to the Shell Gas Station will be via a temporary access road from Limit Ave.

SCOPE OF WORK

The work tasks that will be taking place throughout the duration of the project include;

- Mobilization/Demobilization of Equipment to/from site
- Environmental Protection
- Traffic Accommodation



- Asphalt & Concrete Cutting
- Asphalt & Concrete Removal
- Tree Removal
- Transportation of materials to and from site
- Excavate to remove and replace deep utilities
- Install deep utilities
- Install services
- Reconnect residential services to new mains
- Backfill & Compaction
- Place aggregate materials
- Install new concrete
- Install new asphalt surfaces
- Pavement markings
- Landscaping

Heavy equipment will be working on the roadways for the duration of the project including commercial transportation vehicles. Professional Excavators & Construction Inc. will have flag personnel available onsite as needed to assist with traffic control when vehicles are entering and exiting work areas onto public roadways or temporary public roadways.

DURATION OF WORK

The project will be split in two phases.

The first phase is expected to begin on April 13th, 2020 and end on October 15th, 2020. This phase will consist of the removal of existing trees, concrete, and asphalt, installation of new water main, sanitary sewer, storm sewer, electrical wiring, street lighting, concrete, bottom lift asphalt, temporary pavement markings, and landscaping.

The second phase will be between May 15th, 2021 and July 31st, 2021. This phase will consist of top lift asphalt and final pavement markings.

The work will be taking place between the hours of 7:00 am to 7:00 pm. This time frame is subject to change in the event of an emergency situation and Professional Excavators & Construction Inc. will communicate with appropriate personnel as required.

NOTIFICATION

Professional Excavators will be contacting all Emergency Services 3 days prior to the commencement of work and traffic pattern changes. All affected facilities, residents and businesses will also be notified of any interruptions or traffic route changes.

Notification to residences and/or businesses will be provided in writing. Professional Excavators will provide road closure notices to all affected businesses and residences, a minimum, of 24 hours in advance of any road closures.



SIGNAGE TO BE USED

All signage that will be used on the project will be in compliance with Alberta Transportation guidelines and regulations.

Signs will be placed at heights and spacing between as specified in the Alberta Transportation Traffic Accommodation in Work Zones Manual. Spacing for the Low Volume/Low Speed signage will be 30m apart. On highway 2A, the detour signs will be 75m from the turn, and other signage will be 75m apart unless otherwise indicated. The signs in the Low Volume/Low Speed area will be standard size. The Detour Notification Signage is oversized at be 96"x60". All portable signs will be mounted to A-frame style stands and will be secured where required. All barricades will be equipped with Type A flashing lights when they will be in place during periods of darkness.

Two variable message boards will be set up on Highway 2A for phases 1 and 2 to notify motorists that Railway St will be accessible via Limit Ave only. Access to Railway St will be closed at Laut Ave. The VMB's will read: No Access to Railway St via Laut Ave. Access Railway St via Limit Ave. One VMB will be set up 75m south of Laut Ave/Highway 2A intersection to notify north bound motorists. The other VMB will be set up 75m north of Limit Ave/Highway 2A intersection to notify south bound motorists.

FLAGGING

Flaggers will not be permanently stationed at any of the phases within this project. Flaggers may be used if onsite supervisor feels that there is a safety concern when trucks are entering or exiting the work area onto public roadways.

Where flaggers are required, they will be stationed appropriate distance from work zones. All personnel flagging traffic will don appropriate reflective clothing as per Alberta Transportation Traffic Accommodation in Work Zones Specifications. Flagger personnel will also be certified to do such job.

SPEED LIMITS

All current posted speed limits will remain in force throughout the duration of the project. If the onsite supervisor feels that a restriction in speed limit is necessary for the safety of workers onsite or the public around the work area, they will notify the contract owner.

PUBLIC & PEDESTRIAN ACCOMMODATIONS



Professional Excavators & Construction Inc. is committed to ensuring the safety of all public that will be affected by the Project. To maintain the safety of all personnel affected by the Project, the Contractor will ensure the following;

- Provide posted notice to all public traffic affected by the project 5 days prior to commencement of work activities affecting the regular flow of traffic.
- Provide written notice to all affected residents and businesses within town limits, a minimum of 24 hours in advance of any interruptions – Notices shall be approved by the Town of Crossfield prior to being provided to residences and businesses.
- Maintain pedestrian access to surrounding buildings during construction at all times. This
 includes all residential properties and businesses. A portion of sidewalk connected to the
 buildings on Railway St. and the side streets will remain functional until the roadway is paved.
 Once the roadway is paved, a fenced off walkway will be available to pedestrians to access all
 businesses while the remaining sidewalk is removed and replaced. Alternating temporary
 pedestrian access pathways will also be provided during Phase 3 and 4 from the parking lot east
 of Railway St.
- Set up temporary 6' fencing around all active work areas to prevent egress from public.
- Signage for clarification to public.

EMERGENCY VEHICLE ACCOMMODATION

Professional Excavators will maintain emergency vehicle access to all buildings on the west side of Railway St via the rear laneways while Railway St. is closed. Buildings east of Railway St. will have access through one of the alternating crossings across Railway St from one of the side streets. These will be clearly marked with signage and communicated with all emergency services before changes are made.

EMERGENCY RESPONSE PLANNING

Listed below is the Contractor's generic emergency response procedure to be followed on all jobsites, unless otherwise stated. All Emergency Contact information is available on APPENDIX G

- 1. As soon as the incident is noticed, jobsite activities must be stopped. Notify Site Superintendent immediately.
- 2. Qualified contractors, workers and sub-trades to provide appropriate help to eliminate risks and damage if safe to do so (i.e.: first aid to injured worker, extinguish active fires, shut off valves, provide traffic control, etc.)
- 3. Incident area to be cordoned off.
- 4. Call Police, Ambulance, Fire, Hospital, etc. as per Emergency Contact List located in Appendix G.
- 5. Other workers to gather at specified Muster Point, and, if there is no safe way of controlling the situation, all workers to evacuate site to Muster Point.
- 6. Call Project Manager and Safety Manager.
- 7. Produce Incident Report and forward to Project Manager and Safety Manager.
- 8. Ensure site is safe and obtain permission from Project Manager to resume work.
- 9. Perform a thorough incident investigation as soon as possible, with corrective recommendations implemented immediately.
- 10. Incident findings to be reviewed with workers at the next Safety Meeting.

Emergency Reporting

Any incident involving injury, illness to personnel, loss of revenue or damage to company property or personal property while working must be reported as soon as practical, if not immediately. Any Near Misses that occur during company time must be reported and documented appropriately.

All incidents on the Project will be immediately reported to the Town and Stantec, and the scene will be frozen until direction is provided.

All Sub-contractors must report all incidents as soon as practical to the contractor designated site safety representative or HSE Manager. All reports must be followed up by appropriate documentation within 48 hrs of initial incident.

A written report must be created that includes: a description of the incident, any photographs or other evidence that may assist in determining the cause or causes of the incident, an explanation of the cause or causes of the incident, the immediate corrective action(s) taken, and any long-term action(s) that will be taken to prevent the occurrence of a similar incident or the reasons for not taking action. This written report will be provided to Stantec and the Town of Crossfield within 72 hours of the incident.

ROAD REHABILITATION

Upon completion of each phase throughout the project, the road will be resurfaced with Asphalt and road lines marked as required for the type of roadway. If there are any delays in paving, such as inclement weather, the road will be resurfaced with road gravel until the conditions improve to pave the area.

Phase 4 Detour

















