

**TOWN OF CROSSFIELD  
FEES AND RATES BYLAW  
BYLAW NO. 2018-19**

---

Being a bylaw of the Town of Crossfield, in the Province of Alberta, for the purpose of setting fees for services provided by the Town in accordance with the Municipal Government Act, Revised Statutes of Alberta, 2000, Chapter M-26 and amendments thereto:

**WHEREAS**, in accordance with the Municipal Government Act, 2000, Chapter M-26., as amended; and the Freedom of Information and Protection of Privacy Act, S.A., 1994, Chapter F-18.5, as amended, a municipality must make certain information available to the public; and

**WHEREAS**, in accordance with the Municipal Government Act, and the Freedom of Information and Protection of Privacy Act, a municipality may pass a bylaw establishing fees to charge for providing information.

**WHEREAS**, in accordance with the Municipal Government Act, and amendments thereto, a municipality may pass a bylaw establishing fees to charge for providing goods and services.

**NOW THEREFORE**, the Council of the Town of Crossfield in the Province of Alberta, duly assembled, hereby enacts as follows:

**1.0 TITLE**

1.1 That bylaw shall be known as the “Fees and Rates Bylaw 2018-19

**2.0 DEFINITIONS**

- a) “*Chief Administrative Officer*”: shall mean a person appointed as Chief Administrative Officer under the Municipal Government Act, 2000, Chapter M-26 and amendments thereto.
- b) “*Council*”: shall mean the Council of the Town of Crossfield.
- c) “*Town*”: the Municipality Corporation of the Town of Crossfield.
- d) “*Formal Request*”: shall mean the request for information, which is not routinely provided and requires the completion of a form in accordance with the access to information by the Town of Crossfield.

### 3.0 APPLICATION

Unless prior written approval is obtained from the Chief Administrative Officer, when information is released or services performed, or goods sold by the Town, the Town shall charge fees as established in Schedule A, attached hereto.

All fees and rates are subject to change with the rate of inflation in the follow years and subject to amendment to Schedule A, unless otherwise noted.

**Water and Sewer Utility and Residential Garbage & Recycling rates will be effective for the March 25, 2019 billing.**

Future fees and rates will be amended to the rate of inflation for Alberta as per Stats Canada rounded to the nearest dollar on an annual base, unless otherwise approved by Council.


### 4.0 REPEAL


Bylaw No. 2017-15 is hereby repealed in their entirety.
